HEALTH AGING - THE OVERALL GOAL OF THE PROJECT IS TO IMPROVE THE PREVENTION AND CONTROL OF NON-COMMUNICABLE DISEASES AMONG OLDER PEOPLE IN THREE DISTRICTS IN TANZANIA (MOROGORO, SONGEA AND KIBAHA).
