PHILIPPINES - THE OVERALL GOAL OF THIS PROJECT IS TO PROVIDE DIRECT RELIEF TO AND LONG TERM DISASTER RISK REDUCTION FOR OLDER VICTIMS IN THE ISLANDS OF THE PHILIPPINES THAT WERE AFFECTED BY TYPHOON HAIYAN ON NOVEMBER 8, 2013. OUR TARGET LOCATIONS INCLUDE: LEYTE, NORTHERN CEBU AND NEGROS OCCIDENTAL AMONG OTHER AREAS AFFECTED BY THE TYPHOON. HELPAGE IS CURRENTLY WORKING THROUGH ITS LOCAL AFFILIATE, THE COALITION FOR SERVICES FOR THE ELDERLY (COSE), TO ADDRESS THE NEEDS OF OLDER PEOPLE AND THEIR FAMILIES IN THE PHILIPPINES WHO HAVE BEEN AFFECTED BY THE TYPHOON. THIS PROJECT IS DISTRIBUTING FOOD, WATER, HYGIENE KITS AND NFI KITS, SHELTER DIRECTLY TO THOSE AFFECTED. WHERE MARKETS ARE UP AND RUNNING, CASH TRANSFERS ARE DISTRIBUTED THAT WILL SUPPORT ACCESS TO FOOD, SHELTER NEEDS AND HELP TO REBUILD LIVELIHOODS.
